DISCUSSION

1. The City of Adelaide Standing Orders state as follows:
 175. *Prior to entering the election period, the Chief Executive Officer, in consultation with the Lord Mayor, will prepare an End-of-Term Function proposal (including a proposed budget and function date) for Council's consideration and adoption.*
 176. *The End-of-Term function will be used to acknowledge those people relevant to, or involved with, the Council during the term of office...*
2. It is customary for Council to host the End-of-Term Function in order to acknowledge and celebrate those with whom the City of Adelaide has partnered during the past four year Term. It provides an opportunity to thank those key stakeholders, and to reflect on their contribution to Council's achievements during the term.
3. In the past the event has been held as:
 - 3.1. A dinner for the Lord Mayor, Councillors, Chief Executive Officer, Directors and key City of Adelaide staff (2010-2014 and 2014-2018 Term);
 - 3.2. A larger dinner for over 350 persons (2006-2010 Term).
4. Should Council resolve to proceed with a 2018-2022 End-of-Term Function, the following approach is proposed:
 - 4.1. An event of a similar size and format to the previous two iterations in the Adelaide Town Hall (Queen Adelaide Room) eg a seated dinner reception comprising a two-course meal with alcohol for approximately 40 invited guests.
 - 4.2. On the proposed date of Monday 29 August 2022, to allow sufficient time to make arrangements for the function, and to provide adequate notice to invitees.
 - 4.3. Request the attendance of Her Excellency, Frances Adamson AC, Governor of South Australia and partner as well as the Premier, Hon Peter Malinauskas MP.
 - 4.4. Provide an opportunity for Council Members to bring a partner or a guest to the event.
 - 4.5. Provide for the Chief Executive Officer to invite Directors and key City of Adelaide employees, Chairs of Boards etc.
 - 4.6. Expenditure of around \$3,000 - \$4,000 from existing budget (approximately \$100 per head with final figure dependent on guest numbers).
