## MOTION ON NOTICE

Deputy Lord Mayor, Councillor Martin will move a motion and seek a seconder for the matter shown below to facilitate consideration by the Council:

'That Council:

Requests the Administration provide to the next appropriate Committee of Council meeting;

- 1. A summary of the most recent North Adelaide Local Area Traffic Management Plan's findings in relation to on street parking
- 2. Details of previously advised Upper and Lower North Adelaide population figures, together with a summary of available on street car parking spaces according to parking controls and zones
- 3. The broad Committee and Council discussion in the years leading to and the wording of the resolution of the Council meeting of March 12th, 2019
- 4. The duration of the trial from the date of issue of the first permit to the date of the rescission motion leading to cancellation of the trial, costs of the trial including the placement of "resident exempt" parking signs
- 5. Any advice given to any meeting of Committee or Council about the impacts of the trial leading to the Council rescission of the March 12th, 2019 decision
- 6. Any research about changes to on street car parking in Upper or Lower North Adelaide since the rescission motion
- 7. Costs associated with the re-instatement of the trial, possible sources of funding and an estimate of the time required to re-instate the scheme should Council authorise its recommencement.'

## **ADMINISTRATION COMMENT**

- 1. On 14 February 2017, Council decided that 'Council undertakes a full review of the residential parking permit system and that this review be aimed at increasing the availability of street parks for all residents and businesses.'
- 2. Throughout 2019 and beyond, significant assessment of the parking in North Adelaide and engagement with the North Adelaide community was undertaken. This involved multiple engagements and Council/Committee discussions.
- 3. While the feedback was varied, the most prevalent concerns included the volume of CBD commuters occupying unrestricted parking areas in North Adelaide, and Resident Parking Permit availability.
- 4. In March 2019, Council endorsed a range of changes to parking controls targeting these concerns, along with a 12-month trial to relax Residential Parking Permit criteria.
- 5. In September 2019, in response to feedback from the community, Council revoked many aspects of the March 2019 resolution, with parking controls reverting to their previous state.

- 6. Any permits issued under the relaxed permit criteria were honoured for the 12-month timeframe, ending 30 June 2020.
- 7. Following this, the broad community engagement activities were complemented with more localised, street-by-street engagement and changes to parking controls in many circumstances.
- 8. If this motion is carried, we will provide the report requested, including time and costs associated with reinstatement.
- 9. The table below provides a number of reports as a preliminary response for information for this motion, including the wording of the resolution on 12 March 2019, as sought at point 3 of the motion.
