Purpose

- The purpose of this workshop is to seek Kadaltilla input on the proposed structure and updates to the Adelaide Park Lands Management Strategy (APLMS) as part of the mid term review, as required by the *Adelaide Park Lands Act 2005 (SA)*.
- The mid-term review for the APLMS 2015-2025 was initiated in 2022 and consultation has been undertaken with Kadaltilla, stakeholders and community.
- City Collective has been engaged to make revisions to the APLMS and to prepare the draft strategy which will be finalised in August 2023.



Implications

Adelaide Park Lands Management Strategy 2015-2025	The review will result in an update to the Strategy to align with current conditions including celebration of completed work, updating of in progress actions and the potential introduction of new outcomes and objectives
2020-2025 Strategic Plan	Strategic Plan Alignment – Management and Protection Increase community use of and access to the Adelaide Park Lands

- Phase 1 Consultation Report (complete and tabled at 23 February 2023 Kadaltilla meeting)
- Phase 2 Testing and Shaping the APLMS (in progress)
- Phase 3 Refine and finalise the APLMS with stakeholders and community (planned for May 2023)

- 19 Precincts + 177 Actions

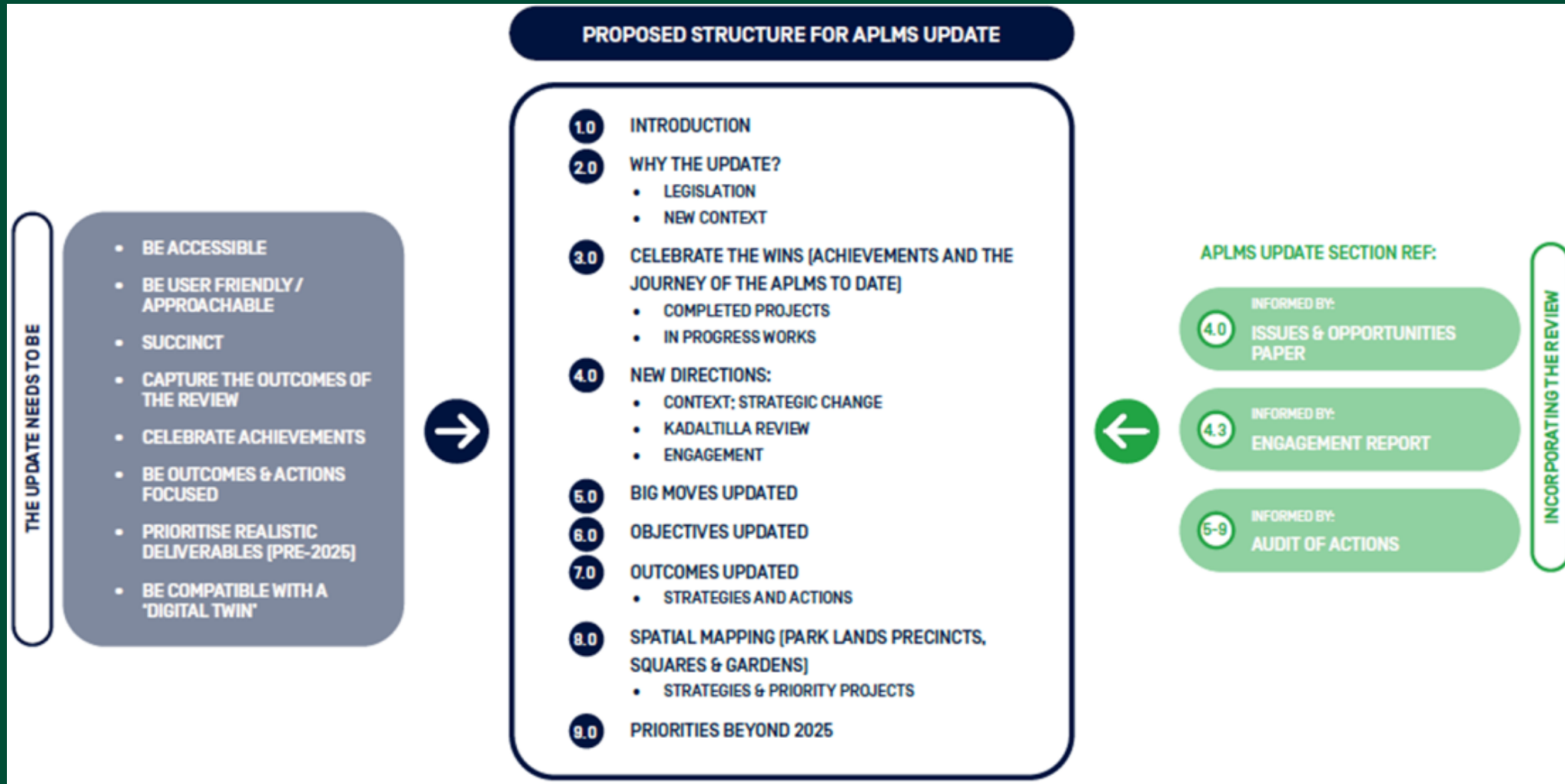


APLMS Proposed Structure

Responsive



Responsive to a changing urban environment that meets the open space needs of Greater Adelaide and inspires people to participate in activities and events leading to an enhanced quality of life.

Iconic



Iconic and celebrated for their distinctive heritage and cultural values and enduring integrity of Colonel Light's plan for Adelaide as "the City in a Park".

Inclusive



Inclusive of all the community providing an enhanced sense of place and ownership and a range of opportunities for social, cultural and economic interaction.

Accessible



Accessible to the metropolitan population via a network of linked parks that connect people to the City, suburbs, hills and coast.

Enriching



Enriching as a place of respite from a rapidly densifying urban environment, providing stimulating sensory, playful and enlightening experiences through a closer connection with nature and beautiful landscapes.

Diverse



Diverse and accommodate a range of activities, experiences and landscapes that are valued by people of different ages, cultures, abilities and interests.

Resilient



Resilient in adapting to a changing climate, enhancing biodiversity and sustaining the quality of user experiences.

Dynamic, active + tranquil places

Places of activity, creativity and tranquillity for everyone that support our changing lifestyles, health and wellbeing.

This outcome addresses:

- Facilities and infrastructure that encourage outdoor recreation and sport
- Destinations and attractions in the Park Lands
- Creation of activity hubs to support a diverse range of recreational needs
- Park Lands as a visitor and tourist attraction
- Management of activities and events
- Enhancement of buildings.

Connected places + spaces

A system of connected and legible places and spaces enabling safe movement via paths and trails linking the City to the suburbs, hills and coast.

This outcome addresses:

- Greater connection of places and spaces through a network of shared paths for walking, cycling and running
- A hierarchy of path networks which link all parks, places and spaces within parks
- Connections linking the City and suburbs with the Park Lands
- Lighting of pathways, ovals and key recreational hubs to improve safety and increase use
- Improved wayfinding and interpretive signage
- Management of car parking on and around the Park Lands.

Welcoming + attractive places

Places of diverse landscapes and natural beauty providing a range of recreational, sensory and stimulating experiences of discovery.

This outcome addresses:

- Establishment of a cohesive Park Lands identity
- Landscaped entry points and edges to welcome and draw people into the Park Lands
- Enhancement of natural, ornamental and cultural landscapes.

Sustainable + enduring places

Places that thrive in the face of a changing climate.

This outcome addresses:

- Management of biodiversity
- Improved management of water and watercourses in the Park Lands
- Sustainable use of water
- Resilience in the face of changing climate
- Role of Park Lands in broader City carbon neutral targets and in managing Urban Heat Island effect.

Memorable + distinctive places

Places celebrating Adelaide's unique natural and cultural heritage

This outcome addresses:

- Protection and preservation of the Park Lands
- World Heritage nomination for the Park Lands
- Identification, protection and interpretation of Kaurna cultural and heritage sites
- Protection and interpretation of the cultural and environmental values of the Park Lands
- Protection and preservation of the National Heritage-listed Park Lands
- Protection and interpretation of the cultural and environmental values of the Park Lands and their cultural landscapes.
